Neighborhood Changes

One of our SLNA officers looked into what's happening at the corner of Kinney Avenue and Lamar Boulevard, where the used car lot Down Under Auto Sales recently vacated.

She went to the City's GIS map on its Web site and located the Site Plans display for the area, found the location number SP-07-0034C for the specific site and then plugged that number into the database of development projects in Austin.

When you search for SP-07-0034C in the development project database, it brings up four items. The most informative is 2007-000034 SP - click on it and scroll way down to the list of Attachments. Apparently, all the pages of the site plan itself are there. It looks like the plans are to put a building toward the corner of the intersection and another toward the side that abuts the first house on Kinney Avenue. You can look at other attachments, too, but this one provides a good "big picture."

Anyone who is remotely interested in this stuff is encouraged to look at these files. This particular case may be beyond the point of us having input on the design, but we need more bodies in our neighborhood to be familiar with the "development world" in preparation for the next development boom. Let's learn on a smaller one such as this, so we can be prepared for the next big one.

This case might be a good one to discuss at our February neighborhood association meeting. There may even be time to discuss with the developer the types of retail we would like to see there if he has not already decided on his tenants.

Texas Hill Country Gardening

One-inch watering soaks winter soil

With continued dry conditions in the forecast, your landscape might need some extra care.

November through February in Central Texas is usually a time of cool temperatures and rainfall more than adequate to provide the water needs for our sleepy winter landscapes. This winter, however, you may need to drag out your sprinklers. Most established plants and Texas natives are well adapted to dry conditions, but recent plantings, turf grass and evergreen plants might require one thorough soil soaking in February and again in March.

If your soil is dry four inches below the surface, consider watering your yard. About one inch of water is the right amount to saturate the root zone in Central Texas soils. To figure out how long to run your sprinklers, set straight-sided cans or cups in your yard and run your sprinklers until the cups are filled to one inch. If your yard is on a slope, you may need to break your watering into two or more separate sessions, allowing time between sessions for water to soak in rather than running off.

Mulch Time.

Now is also a great time to mulch your beds. A two- to three-inch layer of mulch around your perennials, shrubs and trees supports

plants through both winter and summer extremes by keeping the soil moist and moderating soil temperatures.

Avoid pruning your plants and do not fertilize now. Pruning and fertilizer stimulate growth, which can stress plants during drought. New growth is also very susceptible to freeze damage, should temperatures plummet again this winter. Wait until late February to bring out your pruning shears.

Be sure to avoid over-watering this winter. Even if we do not get any significant rainfall, wait until your plants begin growing again in late March or April before you resume a warm-season irrigation schedule.

Consider waiting for better conditions to plant.

If our dry weather continues, this spring will not be an ideal time to do a lot of planting. New plants thrive best with natural rainfall and mild conditions. Without adequate rain, a new landscape will struggle to get established.

Consider this a year to make other types of yard improvements. You may consider adding a cooling arbor, laying a gorgeous walkway or building an artistic new fence.


Echoes of the Drought from the 1950s

LCRA meteorologist Bob Rose reflects on 2008 and shares his 2009 weather predictions

"During the long Texas drought of the 1950s a joke, probably already as old as the state, was told again and again about a man who bet several of his friends it would never rain again, and he collected from two of them." This line is from Elmer Kelton's famous book, "The Time it Never Rained", a chronicle of the terrible record-setting drought of the 1950s in West Texas. In the book, Elmer states that drought, by Texas definition, is a period of severely deficient moisture that laps over from one year into another. "It often lasts two to three years duration. Anything shorter, though it may be serious, is termed a dry spell, as if more annoyance than hardship."

There's no doubt the long drought of the 1950s is one of the worst on record for Texas. During that period, many cities set records for all-time lowest rainfall in a month and in a calendar

year. For example, Austin's rainfall in 1954 was only 11.42 inches, the driest year on record, dating back to 1856. But very dry weather in 2008, although not long enough in duration to qualify as a drought, is matching, if not exceeding, some of the bad drought years of the 1950s. From the Hill Country to the middle Texas coast, rainfall through late December has been roughly 25 to 50 percent of normal. Data for Austin and San Antonio indicate 2008 was the fourth driest year for Austin and the third driest year for San Antonio, as well as the driest year for both cities since the mid 1950s! In reality, the dry weather of 2008 has not just been a dry spell but rather a very serious drought!



The cause of this drought, like most droughts, is not fully understood. It appears to be the result of many different elements in the oceans and atmosphere that have influenced the weather pattern over the central part of Texas most of the year. But in some ways, this drought also seemed to happen by chance, with several large rain storms just missing our region in one direction or another while other storm systems weakened and fell apart just before they moved through. In how many years do you find much of West and deep South Texas wetter than Central Texas?

Scientifically speaking, we're currently in a period caused by a very long-term weather pattern that favors more dry years across Texas than wet ones. So having a fairly dry year right now is not all that surprising. But what is surprising is just how dry this year has been, especially following the very wet year in 2007.

Like the two-year droughts of 2005-2006 and 1998-1999, the drought of 2008 still may continue for another six months to a year, possibly longer. No one knows for sure. But I have some hope the drought may back off some later this winter and going into spring. Looking back at the weather from other years with somewhat similar ocean and atmospheric conditions, specifically 1950, 1974 and 1989, dry weather continued into January of the following year, but some fairly generous rains began to develop February into March in each of those years. If 2009 is similar, we might indeed see more rains across our region late winter and into spring. But will this be a true change in the pattern or just a temporary break? Will the dry spell of 2008 turn into the drought of 2008-2009? Let's certainly hope not.
