# **Update on zoning change** *request for Spaces 2525*

Some of you may remember the discussion at a regular meeting initiated by Stephen Todd, a neighbor and a prospective lessee of a business venue at Spaces 2525. He would like to have a space where he can cut hair for his private clientele. Spaces 2525 is currently zoned LO-MU (with some conditions), which doesn't allow for "personal services". To accommodate that type of business the zoning would have to be changed to GO-MU. Since the GO designation allows more uses than are conducive to the neighborhood Stephen is applying for a zoning change to GO-MU just for the 800+ square feet of his space AND with the condition that the only use can be "personal services". Stephen stresses that this is simply an office space where he can cut hair -- that there will not be walk-in traffic. This case will be making its way through the city zoning process over the next couple of months. #### Upcoming Zoning request on Morgan Lane There are 2 properties for use by the Athena Montessori School,

at 1403 and 1503 Morgan Lane. Between them is a vacant property zoned SF-3 which if developed could accommodate 2 duplexes, a total of 4 households. The School owners would like to get a change in zoning on the middle lot to allow a classroom to be built on the front of the lot and a parking lot on the rear of the lot. This change in use would require a change to NO for the front and GO for the rear. In both requests the neighborhood will insist that there be conditional overlays in the zoning to limit the front lot only to primary school or daycare and the rear lot to use as a parking lot. The applicant is agreeable to the usage limitations. Also under this plan there will be no access to the new classrooms from Morgan Lane, only from Ben White and the rear parking lot. Further, there will be no access to Morgan Lane from the parking lot. These limitations are part of an overall scheme to not exacerbate the traffic volume on Morgan Lane. 
