

2003 COMES TO A CLOSE by Kevin Lewis, SLNA President

As we wind our way toward the end of another busy year for the South Lamar Neighborhood Association, we look forward to next year's challenges and opportunities. SLNA neighbors have accomplished a lot in 2003. We've spoken up on important development cases like Walgreens and CityView Storage (more on those below). We've worked to build community in our area, cleaning streets and researching a possible park. We've continued to learn about the City's operations and been a resource for residents on numerous questions.

The work of the association happens only through the efforts of our volunteers. Officers, committee members and many other neighbors put in countless hours of effort, for which we're grateful. This month we elect officers for 2004. The bylaws state that each term is one year (Jan. - Dec.) and limited to 2 consecutive terms in a position. Hilary Dyer has served diligently as Secretary for two years, so a new volunteer must take her place. We also must re-elect (or elect new folks for) the other four officers. Any current member is eligible to be nominated, either by a Nominating Committee or "on the floor" at the meeting. You must also be a SLNA member to make a nomination. Also at this month's meeting there may be some recommendations to modify the SLNA bylaws. A copy of the current bylaws will be available at the meeting for those who do not have access to the Internet.

SLNA's December meeting has historically been a social event, with the "passing of the torch" from the old officers to the new, followed by potluck snacks and general merriment. We will be asking for one or two neighbors to volunteer as "social coordinators" for the holiday affair, slated for December 18th at our usual time and location.

Walgreens to Revise Plans for South Lamar at Bluebonnet

David Darr, the developer who proposed a Walgreens store at South Lamar and Bluebonnet Lane, has told SLNA he plans to bring out a revised design for the site. City Council voted July 17 to reject the original Walgreens plan, citing intrusion into the neighborhood and traffic and safety impact on Bluebonnet. The SLNA voiced unanimous neighborhood opposition.

City regulations allow a developer to reapply on a rejected site if the new zoning change request is less intense. Darr said if plans for the store were ready he would show them to residents soon, possibly in late October. Maria Corbalan of Maria's Taco Xpress has said the new proposal might include moving her business to a different part of the Village Trailer Park land. Details are not clear and not finalized, but it appears the new plan still includes Walgreens' driveway access to Bluebonnet Lane. We will post notice on the SLNA email list and at Taco Xpress when a meeting is planned with the developer. Please stay tuned.

In other development news: after two years of denying the request, the Board of Adjustment finally granted the parking variance for CityView Storage in September. The multistory storage facility is planned for Kinney Road at Lamar. Neighbors' objections to the variance were based on concerns about traffic, safety and parking on the street. Also, City Council approved changing the zoning of 1704 Fortview to Commercial, but limited to vehicle storage only. That lot is used by Sayther Automotive to store vehicles awaiting repair. The SLNA Executive Committee had voted to take no position on that case.

Keeping [South] Austin Beautiful

When Austin Energy removed most of the shade trees along Bluebonnet Lane, several neighbors decided to do something about the eyesore left behind. With assistance from Richard McHale of Solid Waste Services, SLNA took advantage of the Bulky Items Pick-Up, and pulled all kinds of junk out of that ditch. On the following weekend, several more members filled 18 large garbage bags (4 of which were recyclable cans and bottles) with trash from that same stretch of road. With supplies donated by Keep Austin Beautiful, we made significant improvements to what is still a painfully bare stretch of Bluebonnet, but at least it looks a little bit cleaner.

Silver Lining? Keep your fingers crossed, as there is a chance that the City will continue the work we started, returning that ditch to its original purpose: drainage retention instead of garbage retention!

"Adopt-A-Street" There are several more stretches of roadway in our neighborhood that also need a major cleanup - Clawson Road being the most obvious. Keep Austin Beautiful has offered more help: If SLNA will commit to doing one cleanup project each quarter, Keep Austin Beautiful will create and erect our own SLNA "Adopt-A-Street" sign, fashioned after the Adopt-A-Highway program. Community-wide Fire Ant Management

With recent changes in the weather- rainfall and temperature decline- fire ant mounds seem to be popping up all over! When the weather is hot and dry, fire ants dig deep into the soil to find cooler temperatures. Fall is a great time to tackle fire ants.

Community-wide fire ant management programs can be a beneficial way to overcome the constant battle between homeowners and fire ants. Since most fire ant control methods are executed by individual landowners, there is often rapid reinfestation from nearby, untreated areas. By organizing a community program, the reinfestation boundaries can be pushed further away, resulting in longer periods of time between reinvasion and treatment. Fortunately, many types of bait found in today's market are suitable for large-scale use and can be utilized for community-wide fire ant management.

The "Two-Step Method" is a good method for communitywide treatment of fire ants. This method consists of a broadcast bait treatment twice a year- usually in the spring and fallfollowed by spot treatment of individual mounds that require immediate attention.
