NEIGHBORHOOD PLANNING BEGINS for the South Lamar Corridor

The South Lamar **Combined** Neighborhood Planning Area (SLCNPA) officially launched its planning process with the initial stakeholder workshop on Saturday, October 1st at the Unity Church on Del Curto Road. Facilitated by the City's Neighborhood Planning and Zoning Department (NPZD) it was well attended by residents, non-resident property owners, and business owners from the four planning areas comprising the "SLCNPA": **Barton Hills, Galindo, South Lamar** and **Zilker**. The "South Lamar Planning Area" is comprised of the SLNA area plus **Barton Oaks NA** and the "**triangle**" to our west (bounded by Lamar, Ben White and Manchaca).

The workshop began with a presentation by Senior Planner Mark Walters explaining the purpose and goals of neighborhood planning and how the planning process will work. After a Q&A session, we broke into groups by geography to discuss our areas.

Our area: Generally speaking, our group sees the single-family housing opportunities in our area as our biggest asset to preserve. Opportunities expressed included obtaining public parkland and revitalizing South Lamar Boulevard. The biggest challenges we foresee include:

- · determining the future of existing residential properties along our southern boundary
- · improving non-vehicular accessibility along our streets, with suggestions including more sidewalks and bike lanes.

After our break-out session, everyone reconvened and communicated our results to the group at large, where we learned that our desires are indeed compatible with those of the surrounding planning areas, especially in wanting South Lamar Blvd. to remain navigable for its residents rather than become a thru-way for commuter traffic.

This was the first of several workshops to be held over the course of the **9 - 12 month planning process**. The next workshop is **Wednesday** evening, **November 2nd**, at a place and time to be determined. You will be notified of this upcoming meeting ONLY if you give your contact information to the City's Neighborhood Planners. Whatever your method, you MUST submit your contact information (email or street address) in order to be invited to subsequent meetings.

Meeting invitations and more in-depth surveys will be sent only to those who have taken the time to respond with their contact information. The sooner you join the process, the more you will understand it as we progress.

"Your participation in the planning process is important. A future vision of the neighborhood will be developed and properties will be rezoned as a result of this process." - City of Austin.

Fire Ants

Bait for fire ants in the fall to reduce the number of mounds you have in the spring. Most baits take awhile, so be patient. A new bait formulation gets rid of fire ants within a week; the active ingredient is indoxacarb. If you need fire ants killed quickly, you may want to use an individual mound treatment. Tips on using baits:

- Make sure you have a bait, not a granular
- Broadcasting baits using a handheld spreader can save time
- Use the proper amount of bait for your yard size
 - Most baits are placed at a rate of 1-1 ½ pounds per acre
 - Most people put out more bait than is needed
- Check that ants are foraging before putting out bait
 - Place a hotdog slice or potato chip near a mound, leave for 10 minutes, then check for ant activity
- Do not use stale/ old bait
 - Smell bait to make sure it is not spoiled; spoiled bait smells rancid
 - Store bait sealed in the original container
- Try to get your neighbors to bait around the same time as you do; this will push the reinvasion boundaries further away from your property
