Election of SLNA Officers for 2007

Neighborhood & Corridor Planning by Carol Gibbs, SLNA President

Some time ago, the City Council appointed a Task Force to develop a "Commercial Design Standards" Ordinance which dictates what commercial properties can and cannot look like inside the City.

A relatively new section in these Commercial Design Standards, called "Vertical Mixed Use" (VMU), is meant to encourage more residential development on the outer edges of the neighborhoods (such as Lamar Blvd.). This is one strategy for preserving our neighborhoods' interior character as we brace for the projected doubling of Austin's population over the next 30 years.

As if the Design Standards weren't already a challenge for the layperson to grasp, the VMU section has added another 20+ pages. One component to the VMU Ordinance is that Neighborhood Plan Areas will be asked to "opt-in / opt-out" of VMU zoning for properties facing our respective "Core Transit Corridors" (CTCs - specific roadways that have been identified as such, one if which is South Lamar; Ben White, Manchaca and Oltorf are **not** CTCs).

As participants of the South Lamar Combined NP Area, we will have a limited timeframe in which to make our decisions, along with other "opt-in" opportunities to "nominate" non-CTC properties for consideration of VMU zoning if we so desire. The October 19 SLNA meeting might be our only opportunity to discuss VMU before the 90-day window for input expires. Or we may need to have a brief "business meeting" in conjunction with our December 14 Holiday Party - if members so desire.

As for the rest of our Neighborhood Planning efforts, we have now been at it for a full year and still have not reached consensus on a Future Land Use Map to present to City Council. Partly due to under-staffing at the City, partly due to our frustrations with how our particular planning sessions have been going, we do not even have a date set for our next meeting.

If you don't know what I'm talking about, I encourage you to visit <u>www.ci.austin.tx.us/zoning/slcnpa.htm</u> to see what has been done so far. Many of our original participants have dropped out due to the tedium of the process. If you plan to live in SLNA for years to come, you might want to hear what is being planned for it – and give your input! We are especially having trouble getting Staff to support making Thornton Road all-residential. The above website also has Staff contact information if you'd like to join the process. We need **your** participation if you want to have a say in your neighborhood's future.

- Your membership will be "pending" until a Moderator 6. approves it (usually within a few days).
- Once your residency or home ownership has been 7. verified and a Moderator approves your membership, you will receive an email at the email address you signed up with (if a Moderator needs more information before approving your membership, you will get an email from him/her requesting clarification).
- 8. Once you are a member, you will have access to all the archived email messages of the group, as well as all the photos and files that have been uploaded, on the group's website.

NOTE: You do not have to have a Yahoo email account to join a Yahoo! group. Any email provider will do (although some employers may not allow Yahoo Group memberships on their servers).

SLNA MEMBERSHIP STATEMENT

- Membership in the Association shall be issued on the basis of residency (including renters) or residential property ownership, and timely payment of annual dues or waiver request.
- SLNA boundaries: North--Oltorf; South--Ben White; West--South Lamar/Manchaca; and East--Union Pacific Railroad.
- · Persons meeting the above criteria may request a reduction in dues or a waiver when submitting the Membership Application.
- The privilege of introducing motions and voting shall be limited to those who have joined the Association at least ten (10) days prior to any regularly-scheduled or special called meeting.
